

Sant Pau Hospital, is applying RITMOCORE model in the adoption of innovative interoperable services to support active and healthy ageing and assisted living.




MITMEVA PPI project

Change Management

eLearning platform for professionals

Dashboard to manage the change and assess KPIs satisfaction

Personalized arrhythmia therapy

Provision of **appropriate devices for each patient** (device portfolio availability, stock management, training, etc) and to support remote monitoring

'Adequate device' and **settings** proposed by RITMOCORE platform thanks to data from Remote Monitoring

5th EUROPEAN VALUE-BASED PROCUREMENT CONFERENCE Remote Monitoring

Detection of device malfunctions, change in health conditions (as asymptomatic atrial fibrillation) and alert system triggering

Interoperability standards to integrate with EHR

Coordinated Care

Patient information accessible by professionals

EHR integrated with triggers/alerts sent by remote monitoring platforms

Patient Activation

Education messages for patients and informal care-givers

Coaching platform to handle patient fears

ICT Services

Relationship buyer-contractors: **risk sharing model** based on the defined healthcare **outcomes**



The Pillars

Personalized treatment

Provision of devices and catheters that best suits each patient at any time

Complete and updated range of devices (ICD) and catheters from different manufacturers throughout the duration of the contract

The supplier will need to close commercial agreements with its competitors to offer the Hospital a complete and updated catalogue of products

Remote Monitoring

All devices need to offer the possibility of remote monitoring. The supplier is required to develop an Assistance Centre for Remote monitoring to answer and resolve non-technical queries from patients, and to collect and review all transmissions

Change management

Introduction to Lean Management technology

Reorganization of the spaces for the interventional activity of the unit

(building of two dedicated EP laboratories in the Cardiovascular Interventional Area)

Patient education program


